A payment reference is added to this form before the issuing of any payment instruction.

**Mandate :** We acknowledge that all payment instructions issued by ChildCloud shall be treated by our above-mentioned Bank as if the instructions have been issued by us personally.

**Cancellation:** We agree that although this Authority and Mandate may be cancelled by me us, such cancellation will not cancel the Agreement. We shall not be entitled to any refund of amounts which you have withdrawn while this Authority was in force, if such amounts were legally owing to ChildCloud.
